IABIOMED Privacy Policy

What data do we collect?

IABiomed collects the following data:

- Personal identification information (Name, email address, affiliation/institution, role in your institution)
- Interest in IABiomed (personal or institutional) and comments

How do we collect your data?

You directly provide IABIOMED with most of the data we collect. We collect data and process data when you:

- Register online by subscribing to the newsletter.
- Fill the Google Form expressing your interest in the society.
- Sending your information directly to any responsible by email.

How will we use your data?

IABiomed collects your data so that we can:

- Inform you about updates in the society.
- Inform you when the membership options are available.

Your data will be shared only between the members of the board. The user who will receive this data can change from one year to another.

How do we store your data?

IABiomed securely stores your data at Google Servers.

IABiomed will keep all your data until you decide to remove it.

What are your data protection rights?

IABiomed would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request IABiomed for copies of your personal data.

The right to rectification – You have the right to request that IABiomed correct any information you believe is inaccurate. You also have the right to request IABiomed to complete the information you believe is incomplete.

The right to erasure – You have the right to request that IABiomed erase your personal data.

The right to restrict processing – You have the right to request that IABiomed restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to IABiomed processing of your personal data, under certain conditions.

The right to data portability – You have the right to request IABiomed transfer the data that we have collected to another organization, or directly to you, under certain conditions.

IABiomed uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – IABiomed uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – IABiomed uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. IABiomed sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
